# WTP EMERGENCY DECLARATION RE HIGH SERVICE PUMP

The following Emergency Declaration was proposed by Trustee Katsanis and seconded by Trustee Farone per Wendel's recommendation:

The Village of Albion owns and operates a Water Treatment Plant (WTP) located at 961 Wilson Road, north of the Lake Ontario State Parkway, in the Town of Carlton, NY. The WTP is the primary source of water in Orleans County. Finished water is distributed to the Village of Albion and the Towns of Albion, Barre, Carlton, Gaines, Murray, and Ridgeway; serving approximately 15,000 residents.

The WTP's High Service Pumps deliver the finished water through approximately 210 miles of water lines in the Village's overall transmission and distribution system. The distribution of finished water is critical to supply water for the residents, agricultural irrigation needs and for fire protection throughout most of Orleans County.

The High Service Pumps at the Water Treatment Plant have experienced several cumulative failures that have put the WTP in an emergency situation. Pump No. 3 has failed such that it is unable to

operate at full speed limiting the amount of water it can pump. Pump No. 2 is operating problematic with undesirable noises and vibrations being identified. It is feared that failure is immanent for that pump. Lastly, the WTP has experienced electrical power phase issues that have impacted the outdated and antiquated equipment on the pumps. These issues all lead to the high service pumps at the WTP limiting the amount of water that can be provided causing a serious situation.

This situation has limited the quantity of water and pressure that can be provided to the water plant customers. This reduced capacity limits the ability of the Village to supply the various flow demands while also decreasing the ability to provide fire flow capabilities throughout the County. The reduced capacity could lead to agricultural crop failure due to limited water for irrigation for an extended period during the growing season. It is also likely that a major fire would not be able to be fought as effectively and efficiently with limited capacity from the High Service Pumps at the WTP.

It is Wendel's recommendation that the High Service Pumps deficiencies at the WTP be declared a public emergency in accordance with General Municipal Law §103(4). Absent an emergency declaration, it is projected that it would be until November or December before the project could be bid publicly by normal Village procurement policies and with the requirements of the WIIA grant program. It would likely result in the production of new equipment starting in January or February of 2021 with the work not being completed until November of 2021. Proceeding with the Emergency Declaration will allow the Village to ensure the water supply as quickly as possible while also complying with the NYSEFC WIIA Grant requirements for procurement.
