WTP EMERGENCY DECLARATION RE TRANSMISSION LINE

The following Emergency Declaration was proposed by Trustee Burgess and seconded by Trustee Barry per Wendel's recommendation:

The Village of Albion owns and operates a Water Treatment Plant (WTP) located at 961 Wilson Road, north of the Lake Ontario State Parkway, in the Town of Carlton, NY. The WTP is the primary source of water in Orleans County. Finished water is distributed to the Village of Albion and the Towns of Albion, Barre, Carlton, Gaines, Murray, and Ridgeway; serving approximately 15,000 residents.

The 20" transmission line runs under Oak Orchard Creek/River and supplies potable water to the referenced communities. The distribution of finished water is critical to supply water for the residents, agricultural irrigation needs and for fire protection throughout most of Orleans County.

The 20" transmission line in question was previous repaired in 2019 yet it has since failed causing water to leak from the transmission main. The Village of Albion had planned to make similar repairs to the transmission main in October 2023 which would have allowed for the normal design and bidding process but based on the present condition of the transmission main, repairs to the transmission main should be advanced to April or May as recommend by Wendel Engineers. This declaration of a public health emergency for the immediate design and replacement of the transmission main running under Oak Orchard River to replace the leaking plastic water transmission main with a stronger more

appropriate replacement metal ductile pipe will constitute the Village to not abide by the bidding process.

After the design approval, quotes will be obtained from at least three (3) qualified contractors with the appropriate experience in resolving issues similar to this emergency and the replacement of the faulty transmission main shall be completed at the earliest possible date with consideration of the limitations.
