REBUILD BULLARD PARK COMMITTEE

The Bullard Park Committee also asked for \$2,000 of their donation back they gave the Village last year from the Rock the Park proceeds. They forgot to save out money for operating expenses for this year's Rock the Park event.

SANTA STATUE

The Board of Trustees stated they are open to Mr Tom Rivers and the Betterment Committee researching a Santa statue and where it should be placed in the downtown area.

AIM FUNDS

Mr Tom Rivers stated that the Villages and Towns should make a statement to the Governor's Office regarding not receiving our share of the AIM funds. Trustee Banker stated she had spoken with Lieutenant Governor Kathleen Hochul who was going to look into it, but she never heard back from her.

HANDBOOK DISTRIBUTION
