### **ADOPT RESOLUTION 2015-17 FOR FIRE TRUCK**

The following resolution 2015-17 was proposed by Trustee Farone who moved its adoption and second by Trustee Sidari:

A RESOLUTION DATED JULY 2015 OF THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF ALBION AUTHORIZING THE AWARD OF THE BID FOR THE ASSEMBLY OF PARTICULAR FIRE APPARATUS

WHEREAS, the Village of Albion is the owner of the fire apparatus utilized by the Village of Albion Fire Department; and

WHEREAS, the Village of Albion Fire Department has made the Village Board of Trustees aware of the Fire Department's need of a pumper truck and also a vehicle for support on various emergency calls; and

WHEREAS, it has come to the attention of the Village Board of Trustees that a new truck would be needed for fire emergencies; and

WHEREAS, the Village of Albion Board of Trustees lack the expertise to know or ability to determine what equipment the Village Fire Department needs to maintain the fire service presently provided therefore the Village Fire Department is in a better position to prepare the necessary specifications for the fire apparatus that it deems appropriate to effectively operate its firefighting services for the Village of Albion and those municipalities that have contracted for fire protection service; and

WHEREAS, the Village Board of Trustees had directed the Village Fire Department to prepare the necessary specifications for fire apparatus the Village Fire Department determines would best suit its needs.

WHEREAS, the specifications for the aforementioned fire apparatus were prepared by the members of the Fire Department who have the knowledge and expertise to prepare the proposed specifications. A request for proposal (RFP) was published in the 2nd on June requesting those interested to submit a bid with respect to the fire apparatus in accordance with the specifications prepared by the Fire Department which is attached hereto and made a part hereof as Exhibit A; and

WHEREAS, the specifications were provided to:

Rosenbauer Fire Apparatus Empire Emergency Apparatus, Inc. 3995 Lockport Road Niagara Falls, New York 14305 E-One, Inc. 4760 Camp Road Hamburg, New York 14070

ERV Spartan Colden Enterprises 750 Ontario Street Kenmore, New York 14217

Pierce Manufacturing Churchville Fire Equipment 340 Sanford Road South Churchville, New York 14428; and

WHEREAS, bids were received from E-One, Inc for \$612,595.00, ERV Spartan for \$624,858.00 and Pierce Manufacturing for \$668,796.00; Rosenbauer Fire Apparatus failed to submit any bid; and

WHEREAS, after the bids were submitted to and opened by the Fire Department Apparatus Committee said committee was asked to provide in a written report and recommendation regarding the names and addresses of bidders, the specifications for the fire apparatus and/or the bids submitted by the bidders, the estimated cost by each bidder to build out the fire apparatus, and any exceptions the bidder deemed appropriate to set forth in said bid; and

WHEREAS, the Committee did prepare and submit a report attached hereto as Exhibit B, dated June 20, 2015 regarding the three (3) bids received wherein the Committee provided a narrative as to its examination of the three bids; and

WHEREAS, the Committee recommended that the Village Board of Trustees accept the bid submitted by Pierce Manufacturing, Churchville Fire Equipment for \$668,796.00; and

WHEREAS, the Pierce Manufacturing bid was the highest of the three (3) bids; and

WHEREAS, the Village of Albion Board of Trustees is aware of the competitive bidding process and understands that it is not mandated to accept the lowest of the competitive bids but it must justify selecting any bid other than the lowest bid; and

WHEREAS, the Village Board of Trustees has thoroughly reviewed the report and recommendation of the Committee; and

WHEREAS, it appears that the bids submitted by E-One Inc and ERV Spartan had numerous exceptions and conditions to the original bid specifications, wherein Pierce Manufacturing had but one minor clarification with regards to the hose bed which was also a clarification on the E-One Inc and ERV Spartan bids but overall the bid of Pierce Manufacturing complied with the specifications requested by the Village of Albion Fire Department; and

WHEREAS, the Committee cited deficiencies in the bids submitted by E- One Inc. and ERV Spartan, the first and second lowest bids, and it is clear that those bids detailed fire apparatus which was inferior in quality and product line than the Pierce Manufacturing bid; and

NOW, THEREFORE BE IT RESOLVED, that the Village of Albion hereby awards the bid for the manufacture and fabrication of the fire apparatus as set forth in the attached bid specifications to Pierce Manufacturing in the amount of \$668,796.00 contingent on the Village of Albion securing the funding by way of a permissive referendum and financing for the purchase through a bond anticipation note (BAN).

## **ADOPT BOND RESOLUTION #2015-18 RE: FIRE TRUCK**

The following Resolution 2015-18 was proposed by Trustee Farone who moved its adoption and seconded by Trustee Banker:

BOND RESOLUTION DATED JULY 22, 2015 OF THE VILLAGE BOARD OF TRUSTEES OF THE VILLAGE OF ALBION, NEW YORK, AUTHORIZING GENERAL OBLIGATION SERIAL BONDS TO FINANCE THE ACQUISITION OF A FIRE TRUCK, AUTHORIZING THE ISSUANCE OF BOND ANTICIPATION NOTES IN CONTEMPLATION THEREOF, THE EXPENDITURE OF SUMS FOR SUCH PURPOSE, AND DETERMINING OTHER MATTERS IN CONNECTION THEREWITH.

BE IT RESOLVED by the Board of Trustees of the Village of Albion, New York (hereinafter referred to as the "Village"), by the favorable vote of not less than two-thirds of all of the members of such Board, as follows:

Section 1. The acquisition of one fire truck, which may include apparatus required in connection therewith (hereinafter referred to as "purpose"), is hereby authorized and serial bonds in an aggregate principal amount up to \$668,000 and bond anticipation notes in anticipation thereof (and renewals thereof) of the Village are hereby authorized to be issued to finance said purpose.

Section 2. The maximum cost to the Village is estimated to be up to \$668,000 for said purpose and said amount is hereby appropriated therefor. The plan for financing of said purpose is to provide all of such maximum cost by issuance of serial bonds and bond anticipation notes as herein authorized.

Section 3. It is hereby determined and declared that (a) said purpose is one of the class of objects or purposes described in Subdivision 27 of Paragraph (a) of Section 11.00 of the Local Finance Law, and that the period of probable usefulness of said purpose is twenty (20) years, (b) the proposed maximum maturity of said bonds authorized by this resolution will be in excess of five years, (c) current funds required to be provided prior to the issuance of the bonds or notes herein authorized, pursuant to Section 107.00 of the Local Finance Law, to the extent applicable, if any, will be provided, (d) the notes herein authorized are not issued in anticipation of bonds for an assessable improvement, and (e) there are presently no outstanding bond anticipation notes issued in anticipation of the sale of said bonds.

Section 4. The bonds and notes authorized by this resolution shall contain the recital of validity prescribed in Section 52.00 of the Local Finance Law and such bonds and notes shall be general obligations of the Village and all the taxable real property in the Village is subject to the levy of *ad valorem* taxes to pay the principal thereof, and interest thereon, without limitation as to rate or amount, subject to applicable statutory limitations, if any.

Section 5. It is hereby determined and declared that the Village reasonably expects to reimburse the general fund, or such other fund as may be utilized, not to exceed the maximum amount authorized herein, from the proceeds of the obligations authorized hereby for expenditures, if any, from such fund that may be made for the purpose prior to the date of the issuance of such obligations. This is a declaration of official intent under Treasury Regulation §1.150-2.

Section 6. The power to further authorize the sale, issuance and delivery of said bonds and notes and to prescribe the terms, form and contents of said bonds and notes, including, without limitation, the consolidation with other issues, whether to authorize the receipt of bids in an electronic format, the determination to issue bonds with substantially level or declining annual debt service, all contracts for, and determinations with respect to, credit or liquidity enhancements, if any, and to sell and deliver said bonds and notes, subject to the provisions of this resolution and the provisions of the Local Finance Law, is hereby delegated to the Village Treasurer, the Village's chief fiscal officer. The Village Treasurer and the Village Clerk or Deputy Clerk are hereby authorized to sign by manual or facsimile signature and attest any bonds and notes issued pursuant to this resolution, and are hereby authorized to affix to such bonds and notes the corporate seal of the Village of Albion.

Section 7. The faith and credit of the Village of Albion, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds and notes as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year.

Section 8. After compliance with Section 9 hereof, this resolution shall be published in full by the Village Clerk of the Village of Albion together with a notice in substantially the form prescribed by Section 81.00 of said Local Finance Law, and such publication shall be in each official newspaper of the Village, in the manner prescribed by law. The validity of said bonds and bond anticipation notes issued in anticipation of the sale of said serial bonds, may be contested only if such obligations are authorized for an object or purpose for which said Village is not authorized to expend money, or the provisions of law which should be complied with, at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution.

Section 9. This resolution is subject to a permissive referendum of the qualified electors of the Village of Albion, pursuant to Section 36.00 of the Local Finance Law.
