Discussed the new application and the items the grant writers are working on:

Getting a new cost estimate, a new site map, the petition is online for people to sign, in support of project

Other grants they are working on are the Main Street Grant and the Fluoride Grant. There are many grants out there, the Board of Trustees need to tell them which ones they would like to pursue.

## ALLEN ROAD PRESSURE

Resident Mr Vincent Navarra who lives on Allen Road was present to discuss his water pressure problem. Mayor London will contact Chatfield Engineers to get a blue print of the property where the old water tanks were taken down on the corner of Allen Road and Route 98. The Department of Public Works will check the valves in that area to make sure they are on.

The Water Treatment Plant Chief Operator Kevin Miller asked the Board of Trustees for approval to purchase gauges for the hydrants that could be used on Allen Road. The Board of Trustees decided to hold off on the purchase until after the DPW investigates the valves in that area.
