### RESIDENTS

Mrs Mary Anne Braunbach addressed the Board of Trustees about the Dunn property that is next to hers. Discussed on the following:

Cost to clean the property up

She has been patient for 2 years for him to clean his property up

The trailer on the property is unlicensed and the dumpster will become a nuisance. Mrs Braunbach stated these are code violation that need to be addressed

How residents don't want to take care of their properties and the Village can't afford to clean up the properties in hope of recovering the costs

There are approximately 47 empty properties that need attention

The Attorney will check with the Code Enforcement Officer regarding the violations that Mrs Braunbach referenced

## **BUSINESS'OWNER WITH DOWNTOWN IDEAS**

Downtown business owner Mr David Snell addressed the Board of Trustees about the following:
Mark parking spaces behind Mr Wittman's East Bank Street building. He feels that it
would help residents who park back there not take up two spaces

Angle parking on the east side of Main Street between Bank Street and the canal Pave Waterman Park and turn the space into parking or sell/give away the space to a developer with the stipulation a new building would be constructed

We need to get creative at getting revenue because the state is killing us

The Superintendent of Public Works Dale Brooks will contact New York State regarding the request to have angle parking on the state highway. Trustee Farone will meet with Mr Snell, who is interested in getting involved, to get more details.

### RESIDENT REGARDING FLUORIDE

Albion High School senior Ms Adryan Cheeseboro provide a presentation to the Board of Trustees regarding fluoride in the Village drinking water.

## UTILITY SERVICES REGARDING 1 MILLION TANK

Mr Roger Lindser from Utility Service Group informed the Board of Trustees about the services they can offer regarding restoring the 1 million gallon tank. They can develop a plan and help bring the tank up to date. Trustee Farone will meet with him to get the details and report back to the Board.

## APPROVED TO CREATE A POSITION

Mr Jack Welch from Orleans County Civil Service addressed the Board of Trustees about the steps that need to be taken to create a position of WTP Operator with a Class C license to work in Elba. The Board of Trustees would need to create a Part-time Water Treatment Plant Operator position. Then the employee who currently holds the license would need to take the test again to be hired off the list. A Part-time Water Treatment Plant Operator with a Class C would be different than an operator with a Type IIA license.

#### RL STONE RE: MASTER METER

Mr Scott Bruning from RL Stone discussed the replacement of the master meter with the Board of Trustees. The current meter is outdated and would cost \$4,699 to have it calibrated. The cost of a new meter would be \$8,500 with the DPW installing it.
