#### ALLEN ROAD

The Provisional Superintendent of Public Works Todd Sargent informed the Board of Trustees that National Grid will install a new street light on Allen Road by the curve. National Grid doesn't own a pole on the Village side of the street (north side), so it will be placed on the Town of Albion side (south side). Mr Sargent will send a letter to National Grid stating the Village of Albion will be responsible for the cost of the lighting.

The Board of Trustees would like to see the easement for the sanitary sewer line that is on Vincent Navarra's property on Allen Road. Mr Navarra has requested the line be moved.

### STOLEN URNS

The Cemetery Supervisor will give Chief Nenni the contact information of the officer handling the stolen urns from Mt Albion Cemetery. There has been approximately 20 urns stolen from the cemetery.
