Mayor Theodorakos opened the meeting with the pledge of allegiance at 7:00 PM.

RESIDENT

Mr Tom Rivers, a member of the streetscape subcommittee, addressed the Board of Trustees regarding a proposal for Quarryman's Memorial Park. The approximate cost for the project would be \$130,000; \$25,000 to \$30,000 would come from the Albion NY Main Street Grant Program, the rest through donations. He proposed the park be placed in the green space north of the Presbyterian Church on Main Street. The project would entail a mural on the building north of the parking lot, street lights and trees alternating in the median, a sandstone walkway, 4 flag poles with Ireland, Britain, Italy and Poland's flags behind the 8 foot bronze statue of a quarryman with a hammer in his hand and sandstone surrounding him to create the feeling of working in a quarry. Mr Rivers questioned if the Department of Public Works could do the site work. The Board of Trustees asked Mr Rivers to get dimensions needed for the park. The Village will need to have a survey done and get Chatfield Engineers on board. Mr Rivers stated that they would probably not know until April/May 2013 if there is a good reaction for donations to go forward with the project.

This HEREBY completes the SEQR Process in accordance with 6 NYCRR Part 617 SEQR Regulations.
