BRIDGE COLLASPE MONUMENT

WHEREAS, on September 28, 1859, a horrific tragedy fell upon the Village of Albion while watching a tightrope specialist cross over the Erie Canal on a suspended rope, a group of spectators who had gathered on the bridge traversing the canal, at the main street crossing fell into the canal as a result of the bridge collapsing; and

WHEREAS, the weight of the spectators on the bridge caused the Main Street bridge to collapse; and

WHEREAS, as a result of the collapse of the bridge 15 victims perished; and

WHEREAS, the Albion Rotary Club has requested the opportunity to erect a monument approximately four (4) feet in height made of red granite memorialize this event; and

NOW THEREFORE BE IT RESOLVED, that the Village of Albion does herby consent to the erection of the monument proposed by the Albion Rotary Club upon to memorialize the tragic event under the following conditions

- 1. That said memorial shall be placed on land owned by the Village of Albion on the south side of the Erie canal just east of the existing Main Street bridge, said location to be approved by the Village of Albion; and
- 2. The Village of Albion after consulting with the Albion Rotary Club install a footer sufficient to support the four (4) foot red granite monument; and
- 3. The content of the inscription placed on the monument will first be approved by the Village of Albion prior to the inscription being placed on the red granite, and
- 4. After placement of the red granite monument the Village of Albion will take ownership of said monument and shall perpetually maintain said monument at said location, and

5. The cost of laying of the footer and perpetual maintenance of the monument shall be the sole expense of the Village of Albion and the cost to purchase the red granite inscription and setting of the monument on therefore mentioned footer of foundation shall be the sole expense of the Albion Rotary Club, and be it further

RESOLVED, that the Mayor of the Village of Albion is hereby authorized to execute the necessary documentation if any to facilitate the installation of said monument; and be it further

RESOLVED, as a condition of the execution of said monument the Albion Rotary Club shall transfer ownership of said monument to the Village of Albion to be added to its inventor of assets of the Village.
