Whereas, fifteen lives were lost and the names are now memorialized on a monument in Erie Canal Park

Whereas, Erie Canal Park is also the home of a bench and lamppost created from steel from the Main Street bridge and that steel is one hundred years old

Whereas, this bench was created by Artist Bill Schutt and the bench created by Aric Albright, Kyle Piccirilli and William Malone from the Village Pollution Control Facility

**Now, therefore,** the Village of Albion Mayor (Angel Javier) and Board of Trustees (Joyce A. Riley, Timothy McMurray, William Gabalski, and Gregory Bennett) wish to highlight this history by placing a time capsule in the bench. The time capsule contains:

- Two books created by Albion Central School District MIDDLE SCHOOL Students, titled "the Erie Canal: Ditch of Destiny" and "Charles W. Howard and the Santa Claus School and Christmas Park"
- Business cards from all the businesses downtown
- A thumb drive of all the buildings and landscape of the downtown area
- And two coins minted in 2024

We invite the current Village Board on September 28,2059, to open the time capsule and note the historic changes that the Village has undergone in 35 years. In 2059 it will be the 200<sup>th</sup> anniversary of the Main Street Bridge collapse.


