Transfer of personal property by the Village of Albion to the Albion Joint Fire District

At a meeting of the Village of Albion Board of Trustees held on the 26<sup>th</sup> day of December 2024 at 10:00AM at 35-37 East Bank Street, Albion, New York at which the following were:

PRESENT:

Greg Bennett, Trustee Tim McMurray Trustee William Gabalski, Trustee

Trustee McMurray moved the adoption of the following resolution, Trustee Gabalski, seconded the motion.

WHEREAS, the Town Board of Gaines, the Town Board of Albion, and the Village of Albion Board of Trustees having completed the process of establishing a joint fire district known as the Albion Joint Fire District (hereinafter referred to as AJFD); and

WHEREAS, the AJFD was deemed established as of August 12, 2024, and the Gaines Town Board, Albion Town Board and the Village Board of Trustees for the Village of Albion have each appointed their respective members to fill the five (5) positions as the Fire District Commissioner for the AJFD; and

WHEREAS, the appointed Fire District Commissioners have held various meetings since August 12, 2024, to further the development and operation of the AJFD which is scheduled to assume all governance of the Village of Albion Fire Department as of January 1, 2025, at 12:00 a.m. where the duties of the Village of Albion Fire Department will be fully assumed by the AFJD; and

WHEREAS, as of January 1, 2025, at 12:00 a.m. the AJFD will assume all services which were provided by the Village of Albion Fire Department, therefore eliminating the need for the existence of the Village of Albion Fire Department; and

WHEREAS, pursuant to Section 10-1020 of the Village Law requires the Village of Albion Board of Trustees as Board of Commissioners of the Village of Albion Fire Department and title owner of the vehicles and equipment of the fire department to abolish, in whole or in part, by resolution the Village of Albion Fire Department which was completed on 31st day of December 2024, and transfer over to the AJFD all monies and property of the fire department to the Board of Commissioners of the AJFD with a time certain after service of notice on such officers or commissioners of the action of the Village Board of Trustees; and

WHEREAS, the Village Board of Trustees have served on 31<sup>st</sup> day of December 2024, such notice on the AJFD that it has abolished the Albion Fire Department effective December 31, 2024, at 11:59 p.m. in favor and in furtherance of the AJFD all pursuant to Village Law Section 10-1020.
