## **BOARD REPORT**

### **Personnel:**

1. Trainings for 2025 \*Tentative Dates\*

2. A 2011 Enclosed Trailer was acquired from the 1033 program to be used for our firearms training and possibly a command post for events. The trailer is equipped with heat and air-conditioning.

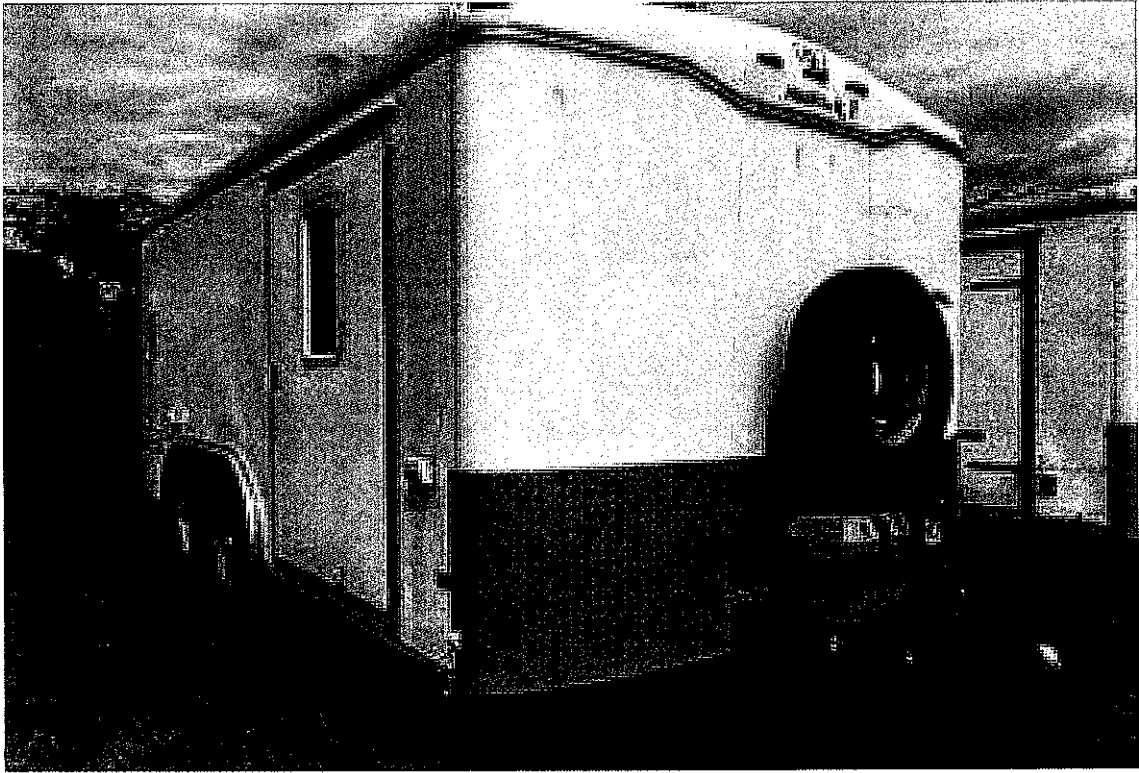
