Subject: Dispute of \$2,000 Water Bill Fine for Tampering Back of Meter House

I am writing to formally dispute the recent \$2,000 fine added to my water bill, referenced under account number 510024300.00 94. The stated reason for this fine appears to be related to a service shutoff and tampering; however, I would like to bring to your attention that I did not receive any physical notice on my door the day before the water service was disconnected.

When arriving home on the date of the shutoff off, my husband had informed me that the water was not working. I was under the impression that I had 2 more days to pay the bill, but had immediately gone on and paid the bill. My husband had entered the basement to check for any possible leaks or damage. When he had confirmed that there was not a leak or damage but that he did see a place where it could easily be turned on and off, he turned the water on with an assumption that a neighbor in the shared building may have done so in anger, as there have been disputes in the past with him that result in negative behaviors. The next day I had been contacted about received payment and informed someone would be coming to turn it back on. I had at this time explained the situation and was informed that there would be a \$1,000 charge for tampering and theft. I was also informed that there was proof that notice was left at our door 24 hours before the shut off but if I would like to dispute this I could write a letter to "the board".

On the date preceding the shutoff, I personally checked and confirmed that no such notice was left on or near my premises by checking on and around the property and front door for footage on the cameras that automatically record movement. Without proper notification, I was denied the opportunity to resolve the situation beforehand, which I believe makes the imposed fine unjust.

I kindly request that you investigate this matter and review any available documentation or records regarding the issuance and delivery of the shutoff notice. Unless proof of proper notice
